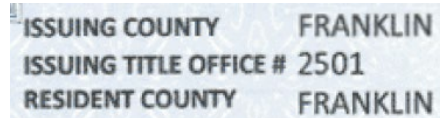

# Ohio Certificate of Title

## Front of the Title

The front of the title shows the current information of the vehicle, owner, and lienholder (if applicable).

1. Issuing County, Issuing Title Office, and Resident County
  - a. Issuing County – this indicates what county processed the title
  - b. Issuing Title Office – this is the number of the office that processed the title
  - c. Resident County – this is the county that the vehicle owner lives in; it is used to determine the sales tax rate



2. Title Type
  - a. The title type can be original, duplicate, replacement, salvage, salvage duplicate or salvage replacement.



3. Title Number and Issue Date
  - a. Title Number – every title has its own unique ten-digit number that can be used to reference the title; the title number can change if the title is replaced or duplicated
  - b. Issue Date – this indicates the date that the title was processed and issued



4. Identification Number, Year, Make, Make Description, Model Description and Body Type
  - a. Identification Number – the Vehicle Identification Number (VIN) is the vehicle's unique seventeen-digit code; the VIN is located on multiple points throughout a vehicle; the VIN stays the same for the lifetime of the vehicle
  - b. Year – designated vehicle year
  - c. Make – the recognizable brand name of the vehicle (Ford, Tesla, Ferrari, etc.)
  - d. Make Description – an extended statement of the vehicle make
  - e. Model Description – the name the manufacturer gives the vehicle (Explorer, Model S, Roma, etc.)
  - f. Body Type – a two-digit code used to identify the style of the vehicle (sedan, truck, SUV, etc.)

5. Mileage and Mileage Notation
  - a. Mileage – Ohio requires mileage disclosure with every vehicle sale; at the time of transfer the seller needs to indicate the current mileage of the vehicle and the buyer must agree to the stated mileage
  - b. Mileage Notation – this can be Actual, Excess, Not Actual or Exempt
    - i. Actual – odometer reading is actual, and the true mileage of the vehicle is being recorded
    - ii. Excess – a 5- or 6-digit rolling odometer has gone over 99,999 or 999,999 miles and started back at 0
    - iii. Not Actual/Non-Actual – the actual mileage of the vehicle cannot be determined
    - iv. Exempt – vehicle manufactured without odometer or gross vehicle weight rate (GVWR) over 16,000 pounds

6. Purchase Price and Tax

- a. Purchase Price – the amount that was paid by the buyer to the seller to obtain possession of the vehicle
- b. Tax – the amount of sales tax collected; based off the county the buyer lives in

7. Notations – these are also referred to as vehicle brands; common brands are Rebuilt Salvage, Manufacturer Buyback, Flood Vehicle, etc. Notations/brands are meant to describe the vehicle’s history and prevent the purchase of a vehicle with undisclosed damage.

## Back of the Title

The back of the title is broken into multiple color-coded sections. The top green portion is the Assignment, the bottom blue portion is the Application. The light brown/tan/grey sections are for the notary to complete.

### Assignment

The assignment is the section where the current owner of the vehicle (seller) transfers ownership to the new owner (buyer). All spaces need to be filled in before having a notary witness the seller's signature.

1. Disclosure of previous vehicle history – select if the vehicle was previously a law enforcement vehicle, has sustained flood damage or was previously a taxi

2. Buyer Printed Name and Address – seller enters the buyer(s)'s full legal name and address.
  - a. Name - The full legal name is most typically the person's name as it appears on their state driver's license or ID. Be sure to include suffix (JR, SR, III, etc.) if applicable. Do not use a nickname; if the person buying the car is named Robert but goes by Bob, the title should be assigned to Robert as that is the person's legal name.
  - b. Address – This is the full physical address of the buyer. The street number, street name, city, state, and zip code are all required for the address. The buyer's address cannot be a P.O. box if the buyer lives in Franklin County.

3. Transfer Date and Purchase Price
  - a. Transfer Date – The selling date needs to be recorded in MM/DD/YY format in the provided space.
  - b. Purchase Price – the selling price of the vehicle needs to be printed on the line provided. This space must contain a number, not words. If the vehicle was sold for \$1,000.00 best practice is to write the price as shown, include the dollar sign and decimal point.

4. Odometer Certification – Mileage disclosure and Mileage Notation
  - a. Mileage disclosure - the seller enters the mileage as it appears on the vehicle's odometer in the boxes. Mileage is recorded as a whole number, do not use a decimal point to show tenths.
  - b. Mileage Notation – this indicates if a true reading of the odometer has been listed. If the odometer has not been altered, the actual box (top box) would be checked. If the vehicle has a 5- or 6-digit odometer that has rolled over 99,999 or 999,999 and started back at 0, the excess box (second box) would be checked. If the odometer reading is not the actual mileage due to a broken odometer, etc. then the not actual/warning odometer discrepancy box (third box) would be checked. If the vehicle was manufactured without an odometer, has a gross vehicle weight rating over 16,000 pounds or is exempt due inheritance then the exempt box (fourth box) would be checked.

## Application

The application is the section where the new owner of the vehicle (also referred to as the buyer) enters their information to apply for a new Ohio title in their name. All spaces need to be filled in before having a notary witness the buyer's signature.

1. Buyer's Acknowledgement of Odometer Certification – this is where the buyer signs to agree to the mileage that the seller printed on the assignment section of the title. This is agreeing that the mileage stated is correct and it will be the mileage recorded along with the mileage notation on the new title.

4. Purchase Price and Tax Exemption

  - b. Tax Exemption – if the buyer is stating that they are tax exempt the tax exemption reason is printed on the line provided along with any support information required.

The full lienholder name and address need to be provided. If the vehicle was paid in full at the time of sale, "None" can be written in this section.

6. Condition of Vehicle/Watercraft – check the good, fair, or poor condition to indicate the condition of the vehicle. The wrecked box should only be checked if applying for a salvage title for a motor vehicle.

7. Print Title – if yes is selected a physical paper title will be printed at the end of the transaction. If no is selected the title can be held electronically by the Clerk of Courts.

8. With Rights of Survivorship and Transfer on Death

- a. With Rights of Survivorship – this can only be checked if two individuals are applying for a title. Upon the death of one owner the other would take title to the vehicle without going through probate court.
- b. Transfer on Death – this allows a beneficiary to be selected to take title to the vehicle upon the owner's death. The beneficiary would not be required to go through probate court. If a beneficiary is to be designated at the time of titling a BMV 3811 Beneficiary Designation/Removal form will need to accompany the title.

9. Applicant is a minor – if the applicant is under the age of 18, they are a minor and require parental or guardian consent to purchase a motor vehicle or watercraft. If the applicant is a minor the date of birth needs to be entered in the provided space and a BMV 3751 needs to be filled out and notarized to accompany the transaction.
