- 5. If the use of a private selling officer is requested, then a Copy of the Order Granting Motion to Appoint Private Selling Officer is filed as an exhibit.
- 6. Filing should also include a one-time **Online Auction Fee** of \$220 per case with the following exceptions:
  - No Online Auction fee if the property is being sold through a private seller.
  - No Online Auction fee for the Prosecutor's Office.
- 7. Filing Fee in the amount of \$600 per parcel.
