Maryellen O'Shaughnessy, Clerk of Courts

As Clerk of Courts, Maryellen oversees the legally appropriate management of documents for the Courts, and issues legal titles to establish ownership of autos and other vehicles. The Clerk's Office employs 200 Deputy Clerks working in 10 different offices located throughout the Courthouse complex and the County. During her tenure as Clerk, the office has established public online access to court documents (Case Information Online/or CIO), has moved the Civil and Criminal divisions into the new Common Pleas Courthouse, and has worked to institute a comprehensive e-Filing system throughout her legal offices. O'Shaughnessy was first elected Clerk in 2008, and was re-elected, unopposed, to her second four year term as Clerk in 2012.



Angela Radney, Chief Deputy/Chief of Staff

Ms. Radney oversees the effective and efficient functions of Auto Title and Legal Divisions.
